Subject: One-Year course of "Diploma in Computer Applications, Business Accounting and Multilingual DTP (CABA-MDTP)"

- I.1. Minimum three years old Registered / Reputed NGO / Institution engaged in educational activities and promotion of Urdu language may apply for establishment of CABA-MDTP centre.
2. Proposals from NGOs satisfactorily running NCPUL Urdu Diploma Course, Arabic Courses or Calligraphy & Graphic Design Training Course (CGDC) may also apply.
3. NGO/Institution should be engaged in educational activities for at least three years.
4. NGO/Institution should have bonafide track record competence and ability.
5. NGO/Institution should be free from any corrupt practices and have capabilities to enforce conditions attached to the Scheme.
6. The accounts of the NGO/Institution will be opened to the audit of the NCPUL.
7. NGO/ Institution must not be situated within the radius of 05 K.M. of other existing CABA-MDTP Centre of NCPUL. Relaxation in distance may be given to the NGOs/Institutions which are running Degree/Intermediate level college or school and affiliated with approved Board/ University, and in Urdu population concentrated area.
8. The applicant NGO has to register on the Government NGO Darpan portal <https://ngodarpan.gov.in> before applying under the scheme.
9. The applicant NGO has to register on the NCPUL's website www.urducouncil.nic.in after registration on Government NGO Darpan portal.
10. One NGO will be given only one CABA-MDTP Centre, anywhere in the country, if they have national jurisdiction. However, preference will be given to such centres which are run and managed by the NGOs registered locally.
11. The NGO, who have already run the CABA-MDTP Centre and closed after phasing out, and their performance is not as per norms will not be considered again for establishment of CABA-MDTP Centre in future.

Phased out Centres

Centres which have already been phased out or will be phased out in the coming years after completion of tenure may be considered for re-establishment of CABA-MDTP Centres at the same location, giving relaxation in existing norms subject to fulfillment of following criteria:

- i. Strength of students should be at least 35, consistently, in each of the past sessions, since last five years. Or at-least 60 students should be passed out in a year, since last five years.
- ii. The Centre must have completed its tenure complaint free.

- iii. The Centre must have submitted registration fees on time and not be listed in defaulter Centres at-least in the last five years.
- iv. Phased out Centres which will be approved on the basis of their past performance shall provide the HW/SW as per requirement of new Centres. Remaining facilities will be provided by NCPUL as per main CABA-MDTP Centres.


An Inspection fee of Rs.10,000/- (Rupees ten thousand only) Shall be charged only from the applicants the organizations which are short listed for Inspection.

X. Registration for Diploma in Urdu Language:

1. Every Computer Centre will necessarily be an Urdu Study Centre for “One Year Diploma in Urdu Language”. Passing in Urdu Diploma is compulsory.
2. **Registration Fee** : The centre will be required to pay the following registration fee per student at the time of admission **in the shape of DD in favour of Director, NCPUL payable at New Delhi**. The yearwise fee payable is as under :-
