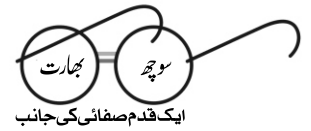

### Notice

National Urdu Council for promotion of Urdu language is working as nodal agency for the development of Urdu language and literature. In this connection, the Council provide financial assistance to Authors/NGOs/other organizations under various schemes. The details are as follows:

- **Scheme of Financial Assistance for the Publication of (Urdu/Arabic/Persian) Manuscripts:** Under this scheme financial assistance is provided for publishing the selection and arranging of rare manuscripts, bibliography, dictionary, books of knowledge, literary, research oriented, reference and criticism books. The dissertations submitted for award of M.Phil, Ph.D. etc. are not covered under this scheme. Only typed manuscripts will be accepted to get financial assistance for publishing. Further, the manuscripts will be considered consisting of at least 100 pages. The Manuscript without comprehensive/detailed 'Muqaddama' will not be considered. Priority will be given on creative research and critical based manuscripts.
  - **Scheme of Financial Assistance for the Projects:** Under this scheme reference books, rare manuscripts extensive list/preparation of vocabulary, reprinting of rare books, published ancient manuscripts including translation, copy of classics, transliteration etc. are considered for projects. Application Form alongwith detailed synopsis consisting of 5-10 pages including Chapterisation of the Project in Urdu, are essential. In this regard, the format of the synopsis is available on the website of the National Council for Promotion of Urdu Language.
  - **Scheme of Bulk Purchase of Books/Periodicals/Journals:** In the bulk purchase scheme rules are the same as fixed for the scheme of financial assistance for the publication of manuscripts. The books financed by any institution or got national or state level awards, will not be eligible for Bulk purchase. Books must be published during previous and current year. The registered (RNI) magazines/periodicals/journals will be eligible to purchase, being published for more than a year and number of copisis at least five hundred.
- Note:** During a financial year application for only one scheme under the above GIA schemes will be accepted from one applicant. Application of more than one scheme from the same applicant will be liable to be rejected.
- **Scheme of Financial Assistance for Seminars/Conferences/Workshops :** Under this scheme financial assistance is provided to registered organizations/universities on the subjects of linguistic, literary and cultural traditions for organising the seminars/conferences/workshops etc.

Voluntary Organizations / Societies / Trusts / other institutions which are registered for last three years at the central or state level and registered on the NITI Aayog NGO Portal Darpan <http://ngodarpan.gov.in>, may be applied. Details of the schemes and related form may be downloaded from the website of National Council for Promotion of Urdu Language. The application may be submitted from 1<sup>st</sup> June to 30<sup>th</sup> June, 2020 on prescribed fully completed performa along with required documents for financial year 2020-2021.
