

## **Frequently asked question (FAQ) for NCPUL**

### **What is NCPUL?**

The National Council for Promotion of Urdu Language (NCPUL) is an autonomous body under the Ministry of Education, Department of Higher Education, Government of India. Set up to promote, develop and propagate Urdu language, Council started its operation w.e.f. April 1, 1996.

### **How can I contact NCPUL?**

### **What are the NCPUL's main objectives?**

The NCPUL's main objectives are:

1. To promote, develop and propagate Urdu language in India and abroad.
2. To produce and publish literature in Urdu language, including books on science, modern knowledge, children's literature, textbooks, reference works, dictionaries, etc.
3. To collect and evolve technical terms in Urdu language for various disciplines of knowledge.
4. To promote and develop computerization of Urdu language to meet the advanced technological requirements of the age.
5. To formulate and implement schemes and projects for teaching Urdu language through different mediums and methods, including correspondence courses.
6. To liaise with the state governments and other agencies in matters relating to promotion and development of Urdu language.
7. To provide financial assistance and guidance to non-government organizations for propagation of Urdu language.
8. To coordinate the activities of the state Urdu academies.
9. To obtain or accept subscriptions, donations, grants, gifts, etc from any person or institution in furtherance of the objectives of the society.
10. To undertake such other activities as may be conducive to the aforesaid objectives of the society.

### **What are the courses offered by NCPUL?**

NCPUL offers various courses such as Diploma in Urdu Language, Certificate in Persian Language, Diploma in Calligraphy and Graphic Design, Diploma in Computer Applications, Certificate and Diploma in Arabic Language, Certificate in Paper Mache and more. For details visit website.

### **How can we apply for scheme in NCPUL?**

To apply for a scheme in NCPUL, you can visit their official website and follow the steps below:

1. Click on the “Scheme” section on the homepage.
2. Select the link for the scheme you want to apply for and click on it.
3. Read the notification carefully and check the eligibility criteria.
4. If you meet the eligibility criteria, download the form or click on the “Apply Online” button.
5. Fill in the application form with all the required details/ documents.
6. Upload all the necessary documents as per the instructions or send the required documents as per scheme requirements.
7. Submit the application form and take a printout of it for future reference.

### **How can I apply for financial assistance from NCPUL?**

To apply for financial assistance from NCPUL, you can visit their official website\_ and follow the steps below:

1. Click on the “Schemes” section on the homepage.
2. Select the link for the scheme you want to apply for and click on it.
3. Read the instructions carefully and check the eligibility criteria.
4. If you meet the eligibility criteria, download the application form.
5. Fill in the application form with all the required details.
6. Attach all the necessary documents as per the instructions. Submit the application form to Farogh-e-Urdu Bhawan, FC33/9, Institutional Area, Jasola, New Delhi-110025

### **What are the eligibility criteria for NCPUL courses?**

The eligibility criteria for NCPUL courses vary depending on the course you want to apply for. For instance, the eligibility criteria for the **Diploma in Urdu Language** course are that students who can read and write Hindi or English language can take admission in this course. There is no age limit for this course.

Similarly, the eligibility criteria for the **Diploma Course in CABA MDTP** is that educational qualification eligibility will be Matric or recognized equivalent qualification. The student should have attained the age of 15 years for matric and 17 years for 10+2 and must be below the age of 35 years on the date of application.

### **What is the NCPUL's CABA-MDTP program?**

The CABA-MDTP program is a computer training program for Urdu speakers. It is a one-year program that covers a variety of IT topics, including computer basics, office applications, and web development in Urdu language to cover language gap in IT Industry.

### **Who is the Present Director of NCPUL?**

**Can I send the proposal again if has been rejected once?**

The proposal once rejected, will not be considered again.
